Aims and objectives

This training will provide you with in-depth know how on various aspects of evidence based medicine (ebM) and health economic evaluation.

On days one and two you will learn how to use the principles of ebM and how health services research is done in various countries.

Days three and four introduce the principles and tools of health economic evaluation and ebM. You will learn how to search for, analyze and evaluate different studies and study types and address in depth the question of how evidence can be demonstrated for a healthcare treatment. After having passed the course you will also be familiar with the concept of HTA (health technology assessment), an assessment model becoming increasingly common in Europe.



Who should attend?

This training is dedicated to healthcare professionals from both the governmental and the private sector. Especially those dealing with health economic evaluation will benefit from this course.

Learning method

This training consists of classroom lectures, group work and research instructions. Therefore each participant is asked to bring his own notebook that is also suitable for internet research (WIFI code will be provided).

Training material

Each participant will receive a detailed course book with all lectures given. He/she will also receive accompanying literature for further research.

Assessment & certificate

The participants will join in several group-work tasks to ensure their active engagement with the training content. Each course day will end with a question and answer session to ensure comprehension.
